SAILING INSTRUCTIONS

1. Rules

The regatta will be governed by the rules as defined in The Racing Rules of Sailing 2021- 2014, ICSA Collegiate Dinghy Class Rules, PCCSC Standing Rules, and by these Sailing Instructions

2. Notice to Competitors

- 2.1 Notices to competitors will be posted on the white board in the Youth Sailing building and will be announced when posted.
- 2.2 Changes to the Sailing Instructions on the water will be communicated to each boat before their warning signal by flying the L flag from the Signal Boat.

3. Signals Made Ashore

- 3.1 Signals made ashore will be displayed from the flagpole located on the Signal boat.
- 3.2 When AP is displayed ashore, '1 minute' is replaced with 'not less than 10 minutes' in the race signal AP.
- 3.3 Changes to the Sailing Instructions made ashore will be communicated by flying the L flag from the flagpole.

4. Schedule of Races:

4.1 The start of another race will, unless otherwise signaled, begin as soon as a reasonable time for return to the starting area has passed since the last boat from the previous race finished.

5. The Courses:

- 5.1 The course will be a standard windward/leeward once or twice around, finishing upwind.
- 5.2 All marks will be orange tetrahedron.
- 5.3 All marks shall be rounded to port.

5.4 Conditions may dictate that a course be shortened at any mark of the course by passing between that mark from the direction of the previous mark and a boat displaying the "shorten course" signal (Code Flag S).

6. Racing Area:

6.1 The racing area will be in the vicinity of D, E and F docks.

7. Warning Flag:

7.1 Code Flag 1 will be the warning flag.

8. Starting and Finishing Lines:

- 8.1 The starting and finishing lines will be between the Signal Boat and an orange Tetrahedron.
- 8.2 Starts will be three minutes.
- 8.3 Individual recall will be signaled with the individual recall flag and a horn.
- 8.4 The finish line is restricted to all boats except those that are finishing.

9. Time Limit:

- 9.1 The time limit for each race will be 30 minutes for the first boat to finish.
- 9.2 Boats failing to finish within 10 minutes after the first boat that sails the course finishes will be scored DNF with a hearing. This changes RRS 35, 63.1, A4 and A5.

10. Protests:

- 10.1 Protests shall be delivered to the Scout building within one half-hour of the competitor reaching shore.
- 10.2 The protest committee shall be comprised of three judges; each competitor involved shall choose one judge each, and the PRO shall be the third judge (except in protests against the race committee). Race committee will be notified of changes in scoring.

11. Scoring:

11.1 All races will be scored by sail number provided. Boats disqualified in a protest hearing shall be awarded a "DSQ" for those races.
