## NOTICE OF RACE

### 1. RULES

- 1.1. The regatta will be governed by the ICSA Procedural Rules, the Racing Rules of Sailing 2021-24 (including Appendix D, team racing rules), the prescriptions of US sailing, the Sailing Instructions and this Notice of Race.
- 1.2. The Sailing Instructions will be available at the check-in table Saturday morning.
- 1.3. The regatta will include limited umpiring, with the possibility of certified umpires.
- 1.4. This regatta includes alumni teams, who will not be a part of the official scores on Techscore.

### 2. ELIGIBILITY & ENTRY

- 2.1. All PCCSC Regular or Provisional Member Schools in good standing are eligible to sail, along with any invited alumni from PCCSC schools.
- 2.2. Each team shall consist of six or more currently eligible sailors or alumni. A team consisting of both current team members and alumni is permitted, but will be scored as an alumni team and therefore will not be on Techscore.
- 2.3. Registration may be limited to 10 teams based on the amount of space and the races required to finish a round robin. If the number of registered teams is greater than the number of available spaces, teams will be given berths with priority given to current teams, then teams consisting of alumni of NW colleges, with a limit of no more than 3 teams of current sailors from any school, and no more than 3 alumni teams from each.

### 3. REGISTRATION & FEES

- 3.1. All teams must RSVP via the PCCSC Regatta Matrix **no later than March 15th, 2024.**
- 3.2. All alumni must submit the Alumni Sign Up Form, distributed to teams via email, **no later than March 15th, 2024.**
- 3.3. An entry fee of \$20 per college sailor and \$25 per alumni sailor will be collected at check-in on the morning of Saturday March 30th.
- 3.4. Additional fees for group housing, food, and charters, may be necessary based on the number of registrants.
- 3.5. Group housing at the Lopez Islander Resort is available at request.
- 3.6. Please find housing and make a ferry reservation in advance. Please note that the ferry from Lopez back to the mainland does not take reservations, and is first-come-first serve.

### 4. BOATS & FORMAT

- 4.1. The regatta will be hosted in FJs and V15s, with at least one flight of each. Attending

teams may be asked to provide boats, sails, and blades depending on the number of teams that sign up.

- 4.2. In the event that boats from off-island are needed, teams that do not bring boats will be asked to pay a \$50 charter fee per team for the weekend to cover travel costs.
- 4.3. This is a team race event. Team races will be 3 vs 3. 12 or 18 boats will constitute 2 or 3 flights depending on the number of registrants. The race committee will work hard to complete as many rotations as possible.

No contestant shall use, either on or off the water, alcoholic beverages (beer, wine, distilled spirits), or use any controlled substance (marijuana, cocaine, etc.), the possession of which is unlawful. An alleged breach of this rule and/or other disciplinary matters that occur may be the

basis for a hearing under rule 69.1. The protest committee for such a hearing will be the Principal Race Officer (PRO) of the regatta along with the Race Committee and umpires.
