1. RULES

- 1.1. The Organizing Authority (OA) is the Pacific Coast Collegiate Sailing Conference in conjunction with WWU Sailing and Lakewood Watersports Facility.
- 1.2. This regatta shall be governed by the current Racing Rules of Sailing (RRS), the prescriptions of US Sailing, ICSA Procedural Rules, ICSA Collegiate Dinghy Class Rules, PCCSC Standing Rules, and this Notice of Race, except as modified by the Sailing Instructions.
- 1.3. RRS 2.2 and D2.3(b) shall be used (as changed by the ICSA Procedural and Collegiate Dinghy Class Rules).

2. ELIGIBILITY AND ENTRY

- 2.1. All schools that are registered and in good standing with PCCSC and ICSA may compete. All entrants must meet ICSA eligibility requirements.
- 2.2. Entry fee is \$100 per team for registration and boats combined, payable to WWU Sailing. Food will not be provided.
- 2.3. Eligible schools will register using the 2023-24 PCCSC Live Schedule. Teams shall confirm their attendance with the host by emailing officers@wwusailing.org before Friday, February 16th.

3. COVID-19 RULES

- 3.1. Masks are recommended but not required indoors.
- 3.2. Participants that are feeling ill are urged to stay home. Those that have been exposed to COVID-19 are required to follow the CDC and WA state precautions regarding exposure.

4. FORMAT

- 4.1. The format shall be a double round-robin between all teams present. Sailoffs shall be conducted to eliminate any ties. We will have limited umpiring.

5. BOATS & EQUIPMENT

- 5.1. 12 FJs will be used for racing. Competitors shall not modify any boat or cause them to be modified in any way. Competitors have the option of rigging the mainsheet purchase either 3:1 or 4:1.
- 5.3. Teams may be asked to provide team race sails, and are expected to return borrowed equipment in good working order.

6. DAMAGE FINES

- 6.1 Damage to boats will result in a \$500 fine to the team(s) at fault. The fine may be adjusted to reflect the level of damage if needed.

7. VENUE & PARKING

7.2. Team check-in and competitors' meeting will take place in Lakewood's Bill McDonald Lounge.
7.3. Parking for cars and trailers (including overnight) is available on site free of charge.
7.4. Lifejackets and wetsuits in limited amounts and sizes are available to borrow free of charge.

8. LAUNCHING & BOAT STORAGE

- 8.1. Teams are encouraged to rig their boats prior to the competitors' meeting, and should plan to launch right after. Dollies may be stored adjacent to the launch ramp during racing. Boats will be stored overnight on dollies in the designated area near the launch ramp.

- 10.1. The Sailing Instructions will be posted online on Techscore prior to the competitors' meeting, and printed instructions will be posted in Lakewood's Bill McDonald Lounge.

11. SCORING

- 11.1. Low point scoring system will be used in accordance with ICSA Procedural Rules. Scoring will be available on Techscore.

12. HOUSING

- 12.1. Housing for this regatta is available upon request. Please contact officers@wwusailing.org by Friday, February 16th if your team would like to request housing.

- 14.1 Competitors participate in each regatta entirely at their own risk. See rule 4, Decision to Race. The host team, university, volunteers, PCCSC, and ICSA will not accept any liability for material damage, personal injury, or death sustained in conjunction with or prior to, during, or after any PCCSC regatta.

15. NOTICE TO ALL PARTICIPANTS

- 15.1. No contestant shall use, either on or off the water, alcoholic beverages (beer, wine, distilled spirits), or use any controlled substance (marijuana, cocaine, etc.), the possession of which is unlawful. An alleged breach of this rule and/or other disciplinary matters that occur may be the basis for a hearing under rule 69.1. The protest committee for such a hearing will be the Principal Race Officer (PRO) of the regatta along with the Race Committee and any venue officials who would like to be present.
