1.1 This regatta will be governed by the current version of the Racing Rules of Sailing (2025-2028), including Appendix D, and the prescriptions of US SAILING, the MAISA Information Bulletin, and the Procedural Rules, except as any of these are modified by these sailing instructions. 1.2 RRS D2 will apply for all races. 1.3 Races from incomplete round robins may be used as races in a subsequent round. 1.4 US Sailing Prescription 63 is deleted. 1.5 The event calls posted on the notice board shall be in effect. 5 <u>FORMAT</u>

RULES

The format shall be determined by the MAISA information bulletin. The following possible formats are listed in order of preference:

- 5.1 A triple round robin of eight teams
- 5.2 A double round robin of eight teams followed by a top 6 round.

6 BOATS & EQUIPMENT

- 6.1 420's or FJ's will be provided for all competitors, who shall not modify any boat or cause them to be modified in any way. Competitors have the option of rigging the mainsheet purchase either 3:1 or 4:1.
- 6.2 The standing rigging shall not be adjusted.
- 6.3 The penalty for infringing instruction 6.1 or 6.2 will be disqualification from all races sailed in contravention of those instructions.
- 6.4 Competitors shall report all damage or loss of equipment, however slight, to the dock/boat committee immediately after arriving on shore or to the Race Committee Finish Boat on the water.

6.5 Breakdowns will be decided using PR 23. Breakdown consideration will not be given for the failure of knots (except at the head of the main when it was determined there was not an opportunity to check it), or loss of cotter pins and rings.

7 RACING AREA

The Racing Area will be Seneca Lake.

8 ROTATION

Rotation will be in accordance with the posted rotation in techscore.

9 <u>MARKS</u>

- 9.1 All rounding marks will be orange balls.
- 9.2 Start and finish marks will be yellow balls.

10 <u>COURSES</u>

- 10.1 The Digital N Course shall be sailed
- 10.2 The starting and finishing lines will be between an orange staff and a ball.

11 STARTING SYSTEM

The starting sequence may be rolling.

12RECALLS12.1A general r

A general recall will be signaled in accordance to PR 18(b)(iii), except that the "1 minute rule" (RRS 30.1) will not be used. (Changes PR 18(b)(iii))

13 PROTESTS

- Image: Protests shall be initiated in accordance with RRS D2 as modified by the PCR.
- 13.2 ICSA Procedural Rules Appendix F is in effect.

14 <u>SCORING</u>

14.1 RRS D3 and D4 shall be used, as modified by PR 25.

15 <u>SAFETY</u>

- 15.1 Competitors who require assistance from rescue boats should so signify by waving arms overhead. A competitor who retires from a race shall notify the Race Committee as soon as possible.
- 15.2 Starts will not be delayed to accommodate capsized boats
- 15.3 Drysuits will be required for all competitors if the air and water temperature are both below 50 degrees Fahrenheit.

16 <u>COACHING</u>

PR 19 shall apply
